TAX-FREE CHILDCARE:

Eligible working parents with children aged 11 or under can get up to £2,000 per child each year towards their childcare costs, or up to £4,000 for children with a disability aged 16 or under.

UNIVERSAL CREDIT CHILDCARE:

Eligible working parents in UK can claim back up to 85% of their childcare cost for children aged 0-16. Plus, eligible parents can access Universal Credit funds upfront, helping those who are starting a job or increasing work hours.

- Each parent must be earning the equivalent of 16 hours per week at national minimum wage but under £100,000 adjusted net income per year
